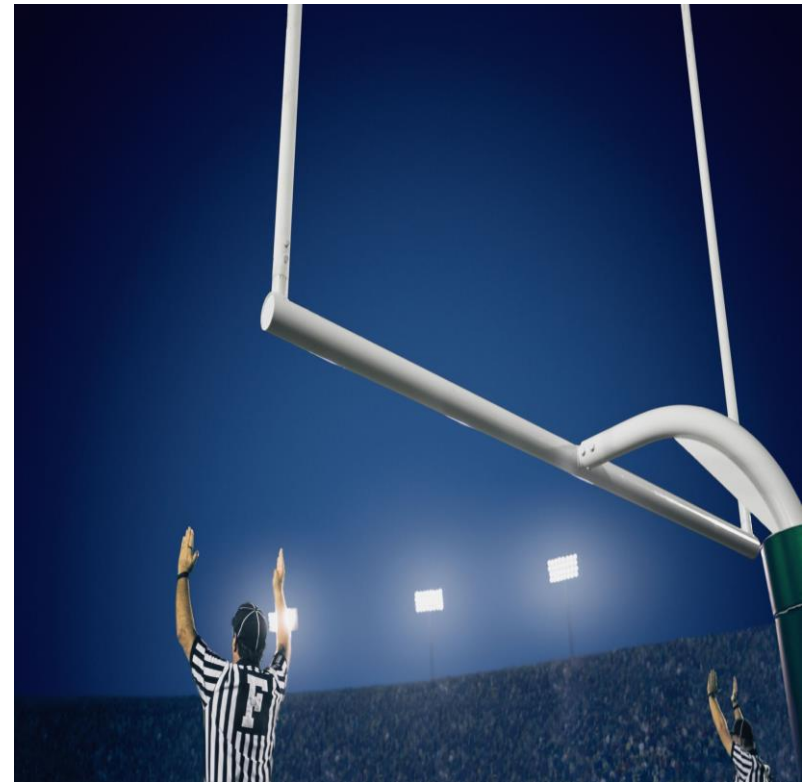

### Our School's Goal for 2023-2024

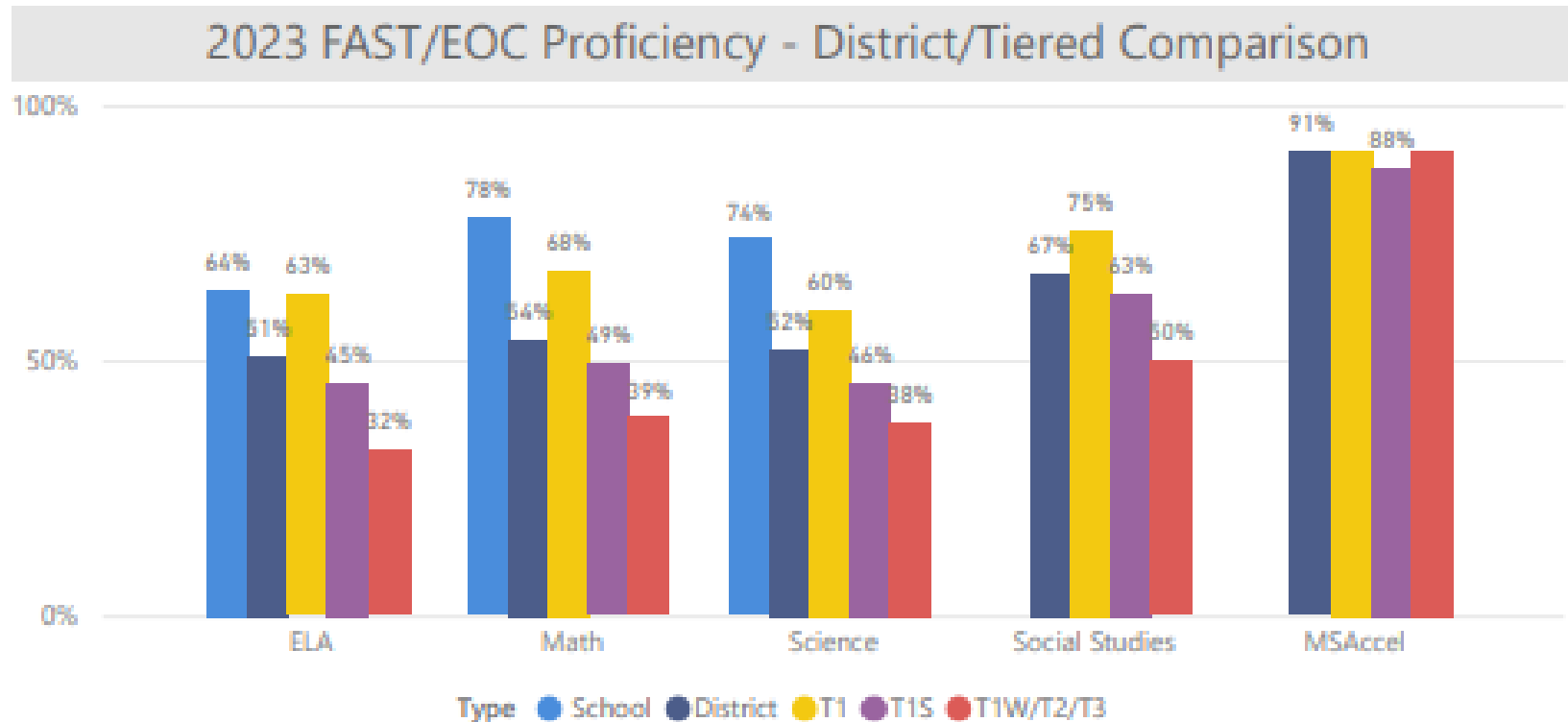
- With the implementation of Differentiated Instruction, an additional 10% of our students in grades 3-5 will score at grade level or above in the area of ELA as evidenced by the 2024 FAST ELA PM3.
- With the implementation of the Data Driven Instruction in Science, an additional 10% of our students in 5th grade will score at or above grade level in the area of Science as evidenced by the 2024 Florida Science Assessment.
- With the implementation of Staff Attendance Initiatives, the percent of teachers with 5.5 to 10 absences will decrease by 5 percentage points by June 2024.
- With the implementation of the Targeted Element of Student Attendance, the percent of students with 16-30 absences will decrease by 5 percentage points by June 2024.

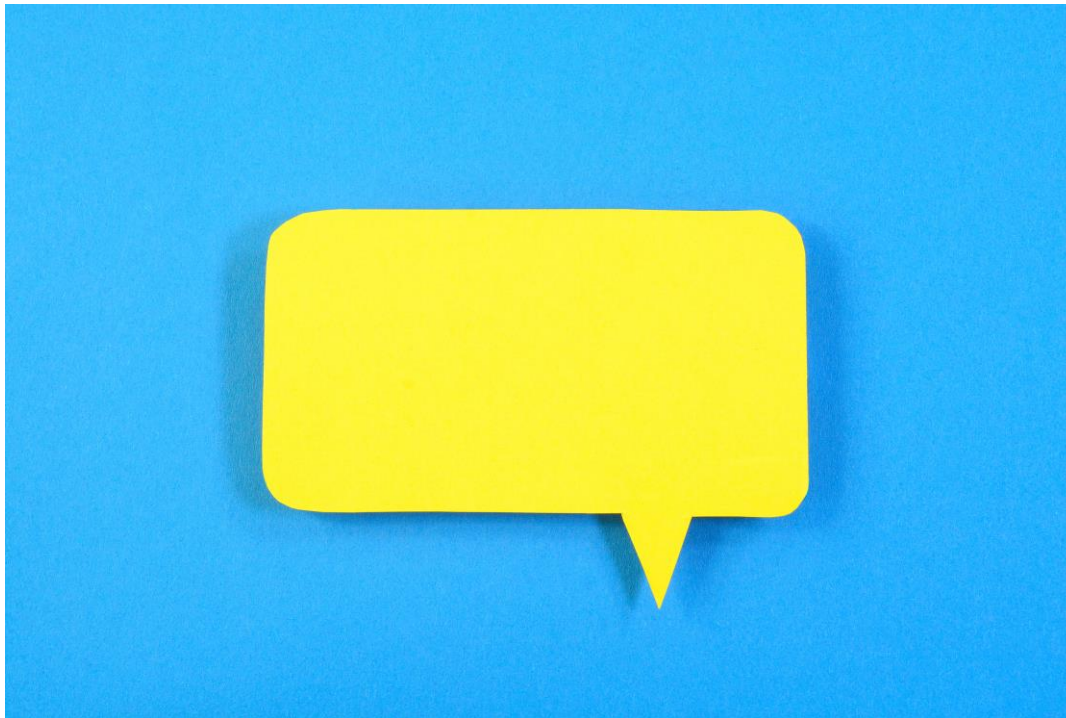
